What is the purpose of this study?

This study is the first stage in a project that aims to understand current knowledge, attitudes, and practices (KAP) of District Veterinarians (DVs) and private veterinary practitioners (PVPs) about emergency animal diseases (EADs), syndromic diagnostics and barriers to requesting EAD exclusion testing.

This information will be used to co-design interventions and field resources to overcome barriers to exclusion testing and support DVs and PVPs to request EAD exclusion testing in clinically appropriate cases.

Why have I been invited to participate in this study?

All private and government veterinarians who practice in NSW and see livestock animals, either as production animals or pets, are invited to participate in the study.

What does this study involve?

Participation will involve the completion of an anonymous online survey. It is expected that the survey will take approximately 20 minutes to complete.

Are there any risks and benefits to me in taking part in this study?

Participation in this study should involve no physical or mental discomfort.
